### I. The procedure for transferring studies from abroad and non-state universities:

- Admission processes for "Study transfer" through the website of the Knowledge and Skills Assessment Agency under the Ministry of Higher Education, Science and Innovation of the Republic of Uzbekistan https://my.uzbmb.uz/ (autumn semester) from July 15 to 5 will be carried out until August (also on this day).
- ❖ Transfer of studies from abroad and non-state universities is carried out through the above site and the following documents are uploaded to the site:
- **—**Passport
- —Transcript (rating book or academic reference)
- ❖ When transferring studies from abroad and from non-state universities, it is necessary to choose a field that is compatible with the field of study, otherwise the application will be rejected.
- ❖ If he wants to study in a field unrelated to his field of study from branches of foreign higher education institutions and non-state universities located in Uzbekistan, he can transfer his studies by making a one-time differentiated contract payment.



- by regional working groups and a payment receipt will be created in your personal cabinet. After that, you can pay via CLICK, PAYME or other applications.
- The amount of mandatory payment for participation in the tests is 165 thousand soums. If the payment amount is not made on time, the permission to participate in the test process will not be formed.
- From July 15 to August 5, applications will be considered by the state commission;
- ❖ For the received applications, tests will be organized by the center of the interactive service portal "Virtual Center" of the Knowledge and Skills Assessment Agency (from August 10 to August 25);
- Between September 5-20, the Ministry will submit the test results to the Higher Education Institution (TDIU).
- ❖ Based on the results, applications for admission to the name of the rector (according to the student's consent) are accepted and he submits an application for a contract from https://kontrakt.edu.uz/;
- Based on the subjects mastered by the student at the higher education institution, the student's course is determined;

- ❖ The student is given a copy of the request letter (in order to get the original documents from the previous HEI), the original of the questionnaire is sent by the HEI that accepted the application to the HEI where the student studied;
- ❖ The applicant is allowed to participate in classes for a period of time until he submits the original of the summary file of his documents and fulfills the terms of the payment contract;
- ❖ Students who have submitted the original documents and fulfilled the terms of the payment contract within the specified periods will be admitted to the ranks of university students.

## I. The procedure for transferring and resuming studies of students between state higher education institutions

- 1. Submitting an online application for transferring, resuming studies, resuming studies and changing the form of education https://transfer.edu.uz /uz
- 2. Deadline for submission of online applications:

For the autumn semester - from July 15 to August 5 every year;

Spring semester for the spring semester - from December 20 of each year to January 20 of the following year;

- 3. The following documents are uploaded to the site for transferring and resuming student studies:
- —Passport copy;
- Transcript (rating book or academic reference);

- **—**Transcript (rating book or academic reference);
- —Documents stating the valid reasons for transferring the student's studies;
- 1. The applicant's application for transfer of studies to another educational field of higher educational institutions (HEIs) or resumption of studies at the HEIs will be considered by the following commissions:
  - Higher education institution commission;
  - Commission of Ministry subordinate to OTM;

### 2. Order!

\* Within the framework of one higher education institution, transfer and resumption of studies of students in appropriate and related areas of higher education and appropriate specialties is carried out on the basis of the order of the rector of this higher education institution.\*

In the following cases, transfer and restoration of students' studies is carried out on the basis of the decision of the ministry (department) to which the higher education institution receiving the student is subordinate:

- to another higher education institution within the framework of one ministry (department) in the appropriate and similar areas of higher education and appropriate specialties;
- from one higher education institution to another higher education institution within the framework of different ministries (departments) in the appropriate and similar directions of higher education and appropriate specialties.
- \* It is allowed to transfer students' studies from one state higher education institution to another only in the following cases:
- when a student applies to transfer his studies to a higher education institution in the area where his spouse permanently lives in connection with starting a family;
- when employees of state bodies apply for transfer of education of their spouse or minor child in case of change of workplace, based on the recommendation of the head of the relevant ministry (department);
